



## Monthly Subscription Agreement

### Terms and Conditions

Our Monthly Subscription plan ("Subscription") allows customers to receive up to 5 washes per month, beginning the first day of the month through the last day of the month, at the Wash Level purchased.

### Payment

A valid credit or debit card is required to process the payment for your Subscription.

- You shall provide Anytime Shine Car Wash with accurate and complete billing information including full name, address, state, zip code, telephone number, and a valid payment method information. By submitting such payment information, you automatically authorize Anytime Shine Car Wash to charge all Subscription fees incurred through your account to any such payment instruments.
- Your Subscription will automatically renew under the exact same conditions unless you cancel it or Anytime Shine Car Wash cancels it. Your credit/debit card will be charged each month on or around the same day of the month you activated the Subscription. For example, if you activate your Subscription on 1/20/17, your card will be charged on the 20<sup>th</sup> day of the month, plus or minus a couple days.
- Should automatic billing fail to occur for any reason, Anytime Shine Car Wash will issue an electronic invoice indicating you must proceed manually, within a certain deadline date, with the full payment corresponding to the billing period as indicated on the invoice.

### Cancelation

### Fee Changes

Anytime Shine Car Wash in its sole discretion and at any time, may modify the Subscription fees for the Subscriptions. Any Subscription fee change will become effective at the end of the then-current Billing Cycle. Anytime Shine Car Wash will provide you with a reasonable prior notice of any change in Subscription fees to give you an opportunity to terminate your Subscription before such change becomes effective. Your continued use of the Service after the Subscription fee change comes into effect constitutes your agreement to pay the modified Subscription fee amount.

### Refunds

Except when required by law, paid Subscription fees are non-refundable.

## **Accounts**

When you create an account with us, you guarantee that you are above the age of 18, and that the information you provide to us is accurate, complete, and current at all times. Inaccurate, incomplete or obsolete information may result in the immediate termination of your account on the Service.

- You are responsible for maintaining the confidentiality of your account and password, including but not limited to the restriction of access to your computer and/or account. You agree to accept responsibility for any and all activities or actions that occur under your account and/or password, whether your password is with our Service or a third-party service. You must notify us immediately upon becoming aware of any breach of security or unauthorized use of your account.
- You may not use as a username the name of another person or entity or that is not lawfully available for use, a name or trademark that is subject to any rights of another person or entity other than you, without appropriate authorization. You may not use as a username any name that is offensive, vulgar or obscene.

## **Changes**

We reserve the right, at our sole discretion, to modify or replace these Terms at any time. If a revision is material we will provide at least 30 days notice prior to a new terms taking effect. What constitutes a material change will be determined at our sole discretion.

- By continuing to access or use our Service after any revisions become effective, you agree to be bound by the revised terms. If you do not agree to the new terms, you are no longer authorized to use the Service.
